What is the overall deductible ? Are there services covered before you meet your deductible ?	Yes. Preventive care, primary care visits, diabetic eye exams, pediatric vision exam and frames and generic drugs are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply.
