What is the overall deductible ?	For network providers \$3,500 individual / \$7,000 family; for out-of-network providers \$10,500 individual / \$21,000 family	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive care, primary care, specialist , emergency room, urgent care visits, diabetic eye exam, diabetic education and testing supplies, pediatric vision exam and frames and prescription drugs are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply.
